## The Partnership of DataPro in Athens for the Kick-off Meeting

28/09/2018



The Partnership of DataPro met in Athens, Greece, for the First Transnational Meeting. On 27<sup>th</sup> and 28<sup>th</sup> September 2018 all partners gathered in Union of Hellenic Chambers of Commerce (UHCC) premises (Day 1) and in Metropolitan College campus (Day 2). The project is co-funded by the Erasmus+ Programme KA3 “Joint Qualifications in Vocational Education and Training” and brings together 10 partners from 4 European Countries (Greece, Belgium, Cyprus and Germany). DataPro aims at establishing a common European framework on technical skills, knowledge and competences in data protection sector narrowing at the same time the differences emerging at business levels in terms of data protection and certification systems. Following the General Data Protection Regulation (GDPR) 2016/679, the Partnership of DataPro recognised the need for a specific occupation profile in the domain of data protection and

GDPR compliance and decided to exploit the Regulation as a new and unexplored employability opportunity.

Data Pro will last 24 months and aims at defining:

- A Joint Occupational Profile for DPOs
- A Joint DPO VET Curriculum accompanied by a detailed WBL Scheme
- An Awareness raising Curriculum on Data Protection for current and future employees
- Data Protection and GDPR Learning Resources for learners and wider audiences and WBL Employer Manual
- On line web platform for “Data Protection Ready” Employees
- A new Certification Scheme for Data Protection
- Concrete Methodology for Quality Assurance and Licencing of DPO VET Curricula

During the DataPRO Project presentation, a Project brief was provided, as well as a concise description of the expected results and products/deliverables. Emphasis was given on DataPRO rationale and objectives and an overview of dissemination activities and expected impact to stakeholders and beneficiaries was explored. Afterwards, a more detailed insight into each WP's methodology was

provided and by the end of the Session 2, the Gantt Chart of DataPRO was presented. During the Kick-off meeting the Partners defined roles and responsibilities with a clear definition of tasks and deadlines for the first part of the implementation. The visual identity of the project was also discussed: the official website of the project will be launched in the following weeks.

## Upgrading the EU Data Protection Sector with New Skills: Comparative Analysis of different data protection curricula

02/04/2019

The Comparative Analysis of different data protection curricula report [has been published](#) on the DataPro Website. The analysis has been conducted by the consortium as a whole and the results, collected and finalized by **ReadLab**. The report aims at presenting and analysing comparatively existing curricula addressed to current and future Data Protection Officers in the project consortium countries and beyond. More specifically, the main objectives of the Comparative Analysis were to:

- Provide an understanding of the different obligations for Enterprises and Organizations emerging from the new Regulation in EU level
- Identify emerging common themes, trends and challenges in Data Protection that skills and competences included in the curricula need to address
- Identify current in play DPO Curricula in Partners Countries - Greece, Cyprus and Germany
- Identify current in play DPO Curricula in third countries and international level

The main findings of the study, underlines that **on the demand side**, the enforcement of GDPR created a new competitive environment, which asks for DPOs to have “expert

knowledge of data protection law and practices”, accompanied by a diverse skill set that includes Interpersonal and communication, organisational and privacy program management, leadership, data privacy strategy, business skills, operational and digital and external engagement. **On the supply side**, the main focus is on the upskill/reskill of the current and future data protection officers in operational, legal and IT skills from a more organizational centered approach. Despite the absence of a common Occupational Profile, there is an unanimity towards certain learning objectives, including knowledge of data protection regulations, of the obligations emanating from the latter, and of the methods to follow to fulfill those obligations, thus achieving compliance. It is observed that the supply side currently offers curricula entailing Introductory, Operational, Legal and IT modules. It is also observed that there is a total absence of soft and/or transversal skills training. Moreover, target groups are the widest possible and none of the identified courses are able to offer specialized skills and especially digital skills in specific market sector and areas. Elective courses and adaptability are missing from all the identified courses. Also, the lack of WBL and/or Apprenticeships component in the

curricula identified and analyzed highlights the missing element of “on-hands” learning. Finally, the absence of

formal recognition of the certifications of DPO training currently available is also noted.

## DataPRO: State of the art comparative analysis report

The **State of the art comparative analysis report** is now available on the DataPro [Official Website](#). The report, conducted by all the partners under the guidance of **ReadLab**, refers to the training needs analysis for Data Protection Officers already conducted in in Cyprus, Germany and Greece consisting of:

1. An online survey targeting DPOs and experts as well as employees involved in data protection processes in their organisation
2. Focus Groups targeting different sectors including Banking and Health sector


3. Interviews with experts, DPOs, and trainers

In particular, the research findings are presented with the aim to:

- Understand how the data protection and privacy environment is being shaped investigating needs and challenges of public and private organizations
- Focus on skills gaps and mismatches between Data Protection Officers (DPOs
- Acquire a deeper knowledge regarding existing training courses, identify best practices and areas of improvements

The main takeaway of this research is the multidisciplinary perspective of the DPO role: **Soft skills** including communication and analytical or problem-solving skills were identified

as must-have for a person with DPO role. Experts and DPOs went a step beyond and accentuated the project management abilities an efficient and productive DPO should demonstrate.

Being able to request and lead the involved persons in order to carry out their tasks and duties are considered the most important competences. The major missing skill is the lack of practical knowledge.

more practical and/or “hands-on” trainings are needed by the market. The most important point that emerged for a DPO training curricula is the need to embed practical trainings with the use of test cases, real-life scenarios, team assignments, etc.
